Application fee must be made by money order or bank cashier's check. Personal checks or credit/debit cards cannot be accepted.

We must be able to verify your identity and review your detailed credit history report as part of our qualifying process. Co-Signer must provide social security number and a valid driver's license or state-issued ID card. We are unable to accept identifications which have been issued outside of the USA. If you have placed a Credit/Security Freeze or Fraud Alert with one or more of the Credit Reporting Agencies, you must request that your report is accessible to us. It may take the Credit Bureau(s) several days to process and complete your request. If we attempt to process your application but are unable to gain access to your credit history report due to a Credit/Security Freeze or Fraud Alert, your application will be rejected and you will be required to pay another application fee if you wish to resubmit.

Co-Signer must currently own (not rent) their home & the Real Property that it is affixed to (located within the Continental United States - 48 Contiguous States), have a superb credit history, and earn at least four (4) times (gross) the amount of rent per month.
